#### THE COURSE

- A two-year course in economics and business: graduates are awarded the "laurea magistrale" or second cycle degree certificate (MSc).
- All seminars and lectures are conducted in English.
- Aims to provide a thorough grounding in international economics and global development, with attention to some specific aspects of business management.
- IBD is designed for candidates from different academic backgrounds.

**Enrolment procedures and deadlines** 

For international students (students holding a non-Italian bachelor degree) a pre-evaluation is required to access the course.

#### **CAREERS**

- IBD combines English teaching with economics, management and development.
- IBD students often find good internship opportunities before graduating.
- After graduation, surveys show a high level of student satisfaction and statistics on IBD graduates employment are good.

  - NGOs working in cooperation and development.
  - European and supranational organizations and national and regional institutions operating internationally.

#### **TECHING METHODS**

 The teaching methods are mainly interactive and require student participation.

#### Class work:

• Attendance and participation in all the activities organised by the lecturers (project work, group work, etc.) are strongly recommended.

#### • Final questionnaire:

• Your opinion is important. At the end of each course fill in the questionnaire very carefully.



#### **LANGUAGES**

All IBD students are required to obtain a certificate of English at B2 level. Students may enrol for IBD without a certificate, but must produce it by the end of the first academic year in order to take second-year exams.

- IBD requirement (English):
  - By September 2024, one of the these certifications is required.
  - Students who do not obtain a certificate by September 2024 will not be permitted to take second-year exams.
- For international exchanges (Overworld, Erasmus+,...)
  - LPT (Language Placement Test), internal test, compulsory to apply for international exchanges.
- General principle: the sooner the better.



#### **INTERNATIONAL EXCHANGES**

IBD offers all students the opportunity to spend a period of time at a foreign university.

- Erasmus+
- Bilateral exchange agreements, including outside the EU
  - Scholarships are usually from the Overwold programme.
- Double degrees (awarded only with participation in the programme)
  - Vilnius University (Lithuania): 1 semester
  - Bochum University (Germany): 1 year
  - Grenoble Ecole de Management (France): 1 year
  - FECAP (São Paulo Brazil): 1 year
  - Usually funded through Erasmus+ and Overworld programmes
- Competitive selection procedures.
- Specific meetings on international exchanges are organised during the year.



#### **OVERWORLD PROGRAMME**

- Students apply directly to the University of Parma and select one of the universities available.
- Some programmes include the dissertation written abroad.
- Applications are usually in January-February, for exchanges in the next academic year (from September), but always check on the website!



## **OTHER ACTIVITIES**

- In order to support first-year students, specific activities are organised:
  - Welcome lesson
  - International students
  - Introduction to Statistics
  - •
- Material and seminars on how to write a dissertation.



#### **EVERYDAY LIFE**

- Lessons are organised over two semesters:
  - Mid-September to December
  - February to May
- Three exam sessions:
  - December-January, 3 exam dates
  - May-July, 3 exam dates
  - September, 1 exam date
- Lectures and exam sessions never overlap (but project work or group work might be subject to continuous assessment).
- Office hours are suspended during holidays.

- The final examination consists of a written dissertation, theoretical or empirical, focussing on a topic related to the degree course.
- What you need is:
  - A supervisor
  - A title and a subject decided with the supervisor
  - Compliance with the <u>deadlines</u> (check the dates with your supervisor)
- Material and seminars on how to write a dissertation.
